Applications postmarked after March 1, 2010 will be accepted if a late fee of \$15.00 is included. Applications will be returned if late fee is not included.

### *Fees*

*Booth Fee:*  
Spaces are 10' deep and 10' wide.  
\$80.00 per booth

*Late Fee:*  
Applications postmarked after March 1, 2010 will be accepted if a late fee of \$15.00 is included. Applications will be returned if late fee is not included.

NO REFUNDS after juried acceptance.

### *Acceptance/Jury Procedure*

This is strictly an arts and crafts fair. Exhibitors must display and sell only their own handcrafted items. **THIS YEAR ALL EXHIBITORS (PAST AND NEW) ARE REQUIRED TO SUBMIT PHOTOGRAPHS WITH THEIR APPLICATION.** Please submit three photos of your work, one of you at work and one of your booth display. Exhibitor applications without photographs will not be accepted. All applications must be signed and include your booth fee. See fee schedule for cost. NO REFUNDS will be given after acceptance. Submitted photos will be returned with acceptance letters or possibly the day of the show.



### *Rules*

*Eligibility:*  
Artist/Crafter must be present the day of the show. Work must be of original concept, design and execution; no kits, commercial molds, etc. Photos submitted for jurying must be representative of the majority of the work to be exhibited. Jurors will use booth photos to judge the overall appearance and make-up of your display. An exhibitor found selling store merchandise, manufactured items, purchased crafts, etc.; will be evicted from the show.

*Exhibits:*  
The Arts and Crafts Fair is held outdoors on our wide paved, Main Street. Exhibitors must supply their own canopies, tables, etc. Show is on rain or shine. Electricity is not available to any booth. *Past exhibitors submitting their application by March 1<sup>st</sup> will be honored the same booth location as last year. We cannot guarantee location after the deadline.* A map of your booth location will be sent along with your letter of acceptance.

*Display Hours:*  
9:00am to 4:00pm. All booths may start set-up at 5:00am and must be ready to operate by 8:45am. All booths must be in operation until 4:00pm. Exhibitors removing items prior to 4:00pm will not be invited to exhibit in the future.

*Parking:*  
All vehicles must be moved off Main Street by 8:00am. **Vender parking, for \$5.00 per vehicle, is located behind Knitt's Hardware Hanks. This location is in the middle of Main Street, which is in the middle of the show.** Handicapped vendor parking is also at this location. Free parking is available on some of the side streets and off Marsh Road. Please see a Chamber volunteer for questions regarding designated parking areas. There is no parking in the Boulder Junction Marketplace parking lot. This is for customer use only and the service organization permitted to sell food.
